A call for tenders is open for one Bachelor Scholarship within the scope of the projects REFLECT - Raising awareness and stimulating Executive Functioning and social emotional Learning by integrating Evidence based strategies in the Classroom to empower pupils, Teachers and parents, financed through ERASMUS+ - KA2 (Projecto 2019-1-BE02-KA201-060353) (Set. 2019-Set.-2022) and ASUMIE – Additional support and Mediated learning in Inclusive education, financed through ERASMUS+ - KA2 (Projecto 2020-1-BE02-KA201-074751) (Set. 2020- Set. 2023), under the following conditions:

**Scientific area:** Psicologia

**Admission requirements:**

- \_ Degree in Psychology, or equivalent to the desired Scientific Area. **Eliminatory factor;**
- \_ Attendance of the Master's in Educational Psychology. **Eliminatory factor;**
- \_ Scientific experience in the field of construction and validation of instruments using SPSS;
- \_ Preferably having knowledge and experience in the areas of intervention in educational contexts (children, teachers, parents);
- \_ Good analysis skills, data collection and bibliographic analysis;
- \_ Good command of English and Portuguese, these will be the working languages;
- \_ Good ability to work autonomously and organized.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for “**BI**” (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

**Work plan:**

The work plan foreseen for the Exchange is related to the activities of the REFLECT and ASUMIE projects in the scope of the elaboration and dissemination of products and includes:

- support in the implementation and contacts necessary for the implementation of the project's tasks/Outputs;
- support in the development of project tools/outputs.

- support in the organization and promotion of the Workshops and contacts with the academic and professional community foreseen in this project;
- support in the production of project reports and deliverables and possible publication of scientific results.

**Applicable legislation and regulations:** The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template [https://www.fct.pt/apoios/Minuta\\_Contrato\\_Bolsa.docx](https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx), pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: <https://www.fct.pt/apoios/bolsas/regulamento.phtml> and other applicable rules.

**Place of work:** The work will be developed at the University of Évora, under the scientific guidance of the Professor Adelinda Candeias.

**Duration of the scholarship:** The scholarship will have a duration of six months, starting on May of 2022. The scholarship contract may be renewed up until the end of the funding project's "ASUMIE" budget allocation.

**Amount of monthly maintenance allowance:** The amount of the scholarship corresponds to € 875,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<http://fct.pt/apoios/bolsas/valores>), payments being made monthly, by check or bank transfer.

**Selection methods:** The selection methods, with the respective valuation, to be used will be the following:

- . Rating: 50%
- . Adequacy: 50%

**Curriculum Evaluation: 50%**

- . Scientific Activity: 50%
- . Experience in the requested topics: 50%

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list, by final grade obtained posted in a visible and public place (Colégio Luís Verney

– Escola de Saúde e Desenvolvimento Humano), being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

**Application deadline and submission of applications:** The tender is open from 8<sup>th</sup> April to 26<sup>th</sup> April 2022 and the results of the selection will be published by 29<sup>th</sup> April 2022.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificate of qualifications and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
