Contest for Research Scholarship for Graduates – 1 vacancy

May 24, 2022

A call for tenders is open for one Bachelor Scholarship within the scope of the project Interdisciplinary Centre for History, Culture and Societies University of Évora - CIDEHUS, UIDB/00057/2020, financed by national funds through FCT / MCTES, under the following conditions:

Scientific area: Languages and Literatures / Digital Philology.

Admission requirements:

- -Degree in the scientific area of the competition;
- -Enrollment in a master's or doctoral course in the scientific area(s) of the project;
- -Computer knowledge from the user's perspective.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

1. Transcription into text format of the fragments published under the title *História do Futuro*, from the edition by Lúcio de Azevedo, reproduced in Sérgio e Cidade 1953 (pp. 1-160).

- 2. Participation in the collation with the original texts (Torre do Tombo: Inquisition of Lisbon, Folder 01664, Rolo 1427 1427c) and in the definition of the transcription criteria, together with the senior researchers.
- 3. Participation in the selection and adaptation of natural language processing tools to Vieira's 17th century texts, together with senior researchers.
- 4. Participation in the organization of the work's lexicon, together with the senior researchers.
- 5. Participation in manual annotation tasks.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt and other applicable rules.

Place of work: The work will be developed at the Interdisciplinary Center for History, Culture and Societies of the University of Évora or online, under the scientific guidance of Professor Ana Paula Banza.

Duration of the scholarship: The scholarship will last for 6 months, starting in June 2022. The scholarship contract can be renewed for another 6 months.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to € 875,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (http://fct.pt/apoios/bolsas/valores), payments being made monthly, by check or bank transfer.

Selection methods: The selection methods to be used will be the following:

Curricular assessment (100%):

- -Average degree (50%)
- -Other relevant training (25%)
- -Participation in congresses/publications (25%).

Composition of the Selection Jury:

President: Prof.ª Doutora Maria Filomena Gonçalves 1st member – Prof.ª Doutora Ana Paula Banza 2nd member – Doutora Helena Freire Cameron 1st substitute member – Prof.ª Doutora Fernanda Olival 2nd subsitute member – Doutora Renata Vieira **Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place in Palácio do Vimioso, being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from May 25 to June 9, 2022 and the results of the selection will be published by 13 of June of 2021.

Applications must be formalized, mandatory, by sending an application letter with the following documents:

- a) Curriculum Vitae;
- b) Certificate of qualifications;
- c) Letter of motivation;
- d) Master's or PhD enrollment certificate;
- e) Other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
