Contest for Research Scholarship for Graduate Studentr - 1 vacancy

7 of July of 2022

A call for tenders is open for one Graduate Research Scholarship within the scope of the project CHRC - Comprehensive Health Research Centre, with the reference **UIDB/04923/2020**, financed by national funds through FCT/MCTES - *Financiamento Plurianual de Unidades de I&D 2020-2023*, under the following conditions:

The Research Grant is intended to carry out R&D activities by:

Graduates aiming to consolidate their scientific training through the development of research work leading to the achievement of the respective academic degree integrated or not in R&D projects;

Scientific area: Health Policies and Health Services Research

Admission requirements:

Degree in the area of health sciences or social sciences, experience in qualitative research projects, good knowledge of scientific writing in English.

Preferred factors:

experience in the presentation and publication of results of scientific research works (articles and oral presentations); experience in applied health research; certification of the level of oral and written expression in English (level C1 or higher, according to the Common Framework of Reference for Languages); Immediate availability; experience in project management.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for “**BI**” (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

Conducting a rapid literature review; supervised conduct of focus groups; ethnography; semi-structured individual interviews; collaboration in the analysis and interpretation of qualitative data; Writing scientific reports and articles.

This plane will be done within the scope of the project “Reforming the reform: an evidence-based financing model for the Portuguese primary care (REF2PRIM)”, of Escola Nacional de Saúde Pública and Nova Medical School of Universidade Nova de Lisboa, in the scope of Research Grants of Comprehensive Health Research Centre (CHRC).

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, as set in the template https://www.fct.pt/apoios/Minuta_Contrato_Bolsa.docx, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP in force, regulation nº950/2019 of December 16, 2019: <https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt> and other applicable rules.

Place of work: The work will be developed at Nova Medical School da Universidade Nova de Lisboa, under the scientific guidance of the Professor Bruno Heleno, Professor Daniel Pinto, Professor Julian Perelman and PhD Mário Santos.

Duration of the scholarship: The scholarship will have a duration of 12 months, starting on September of 2022, with no possibility of contract renovation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €875,98, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<http://fct.pt/apoios/bolsas/valores>), payments being made monthly, by check or bank transfer.

Selection methods: The selection methods to be used will be the following: curriculum evaluation and interview (the interview will only be carried out for candidates with a score higher than 16 in the curriculum evaluation), with the respective valuation of 80 % (curriculum evaluation) and 20 % (interview).

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place, web page of Escola Nacional de Saúde Pública: <https://www.ensp.unl.pt/> , being the candidate approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from 8 of July to 22 of July of 2022 and the results of the selection will be published by 29 of July of 2022.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, cover letter and motivation (in English), certificate of qualifications, proof of enrollment in study cycles leading to the award of academic degrees or in courses not awarding an academic degree, and other relevant supporting documents considered relevant.

Applications must be sent by email to JPerelman@ensp.unl.pt , the reference: **Bolsa Licenciado REF2PRIM** must appear in the subject of the message.

Please note that any necessary clarification should be sent to the same email address.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
