#### Master SCHOLARSHIP - 1 VACANCY

14 of May of 2024

A call for tenders is open for one Scholarship for Master within the scope of the project INOVCIRCOLIVE, reference PRR-C05-i03-I000208, financed by national funds through PRR - Plano de Recuperação e Resiliência for 2023- 2025, under the following conditions:

Scientific area: Agricultural Sciences

#### Admission requirements:

Master's degree in the area of Agricultural Sciences, Chemistry, Biochemistry, Food Engineering and Biotechnology. Written and oral command of Portuguese and English is mandatory. Written and oral command of the Portuguese language is mandatory. The application must include detailed information about the candidate's profile, with explicit reference to the experience acquired, namely the classification obtained in the various curricular units of the master's degree curriculum; carrying out academic work and scientific articles and professional experience. To candidates from countries outside the CPLP ((Community of Portuguese Speaking Countries) will be required to provide proof of proficiency in the Portuguese language.

**Preferential conditions**: Preference will be given to candidates who have proven experience in the areas of food analysis, through physical-chemical and chromatographic methods.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

#### Work plan:

Ensure that tasks are carried out in accordance with the INOVCIRCOLIVE project activity plan, namely chemical analysis in laboratory of olive pomace and olive oil samples.







Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP nº950/2019 in force. regulation of December 16. 2019: https://files.diariodarepublica.pt/2s/2019/12/241000000/0009100105.pdf and other applicable rules.

**Place of work**: The work will be developed at Oenology Laboratory of the University of Évora, under the under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Professor Raquel Marta Neves dos Santos Garcia, who must draw up an opinion on the final activity report of the scholarship (**Annex II**), according to the draft in **Annex III**.

**Duration of the scholarship(s):** The scholarship will have a duration of 12 months, starting on June of 2024. The scholarship contract may be renewed *until the end of the funding project's budget allocation*.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €1259,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM\_atualizacao-2024.pdf">https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM\_atualizacao-2024.pdf</a>), payments being made monthly, by check or bank transfer.

**Selection methods**: The selection methods to be used will be the following: 20 points (100%) for the curricular evaluation. Based on the jury's evaluation, candidates may be considered for an interview, in this case, the valuation will be 12 values (60%) for the curriculum analysis and 8 values (40%) for the interview.

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place of Rural Engineering Department, being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.







**Application deadline and submission of applications**: The tender is open from <u>15 of May of 2024 to 29 of May of 2024</u> and the results of the selection will be published by <u>15 of June of 2024</u>.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificate of qualifications, motivation letter and Certificate of proficiency in the Portuguese language (except for candidates from the CPLP - Community of Portuguese Speaking Countries).

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
