A call for tenders is open for one Scholarship for Graduate within the scope of the project of CIDEHUS – Centro Interdisciplinar de História, Culturas e Sociedades da Universidade de Évora, UIDB/00057/2020, entitled UF&Port - The relationship between urbanism and the railway in Atlantic port cities on the Iberian Peninsula and in Brazil, financed by national funds through FCT/MCTES, under the following conditions:

Scientific area: History

Admission requirements:

Bachelor's Degree in History, or Architecture, or Cultural Heritage or related field; presentation of CV; proof of knowledge of archival research; knowledge of using databases and spreadsheets; skills in image collection; skills in creating a website and maintaining it.

For non-native speakers of Portuguese or Spanish, proof of written and oral proficiency at a high level in at least one of these languages is necessary.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

- 1) Research in port, railway and municipal archives, repositories, libraries and digital bibliographic databases on Portuguese, Spanish and Brazilian Atlantic port and railway cities that still maintain commercial or passenger mobility relations.
- 2) Creation of a map identifying the cities studied.
- 3) Filling in the database.
- 4) Collaborating in the organisation of events.







5) Participation in events and publication of results.

The work will be carried out under line 2 of CIDEHUS - Heritage, Literacies and Cultural Diversity.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP regulation nº950/2019 of December 2019: in force, 16, https://files.diariodarepublica.pt/2s/2019/12/241000000/0009100105.pdf and other applicable rules.

Place of work: The work will be developed at CIDEHUS – Centro Interdisciplinar de História, Culturas e Sociedades of the University of Évora, under the under the general coordination of the Administrator of the University of Évora and the scientific guidance of the PhD Fernanda de Lima Lourencetti, Professor/PhD Ana Cardoso de Matos and PhD Alexandre Ramos, who must draw up an opinion on the final activity report of the scholarship (Annex II), according to the draft in Annex III.

Duration of the scholarship(s): The scholarship will have a duration of six (6) months, starting on july of 2024. The scholarship contract may be renewed up to six (6) months and (ex.) a maximum of eighting (18) months or until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €990,98., according to the table of scholarships awarded directly by FCT, I.P. in Portugal (https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf), payments being made monthly, by check or bank transfer.

Selection methods:

Selection will take place in two phases:

Phase 1 - Curriculum evaluation, valued from 0-100 points.

Phase 2 - Interview, in person or online, in Portuguese/Spanish, of the three candidates with the highest scores in Phase 1.

The final classification for each of these three candidates will be the average of the score from the CV assessment and the score obtained in the interview.

In Phase 1, the assessment and scoring will be as follows:

1. Degree in History or Architecture, with attendance at UC's with cultural heritage content = 10 points (on a scale of 1 to 10);







- 2. Postgraduate training completed in History, Architecture or Cultural Heritage = 10 points (on a scale of 1 to 10);
- 3. Experience of working with archives = 10 points (on a scale of 1 to 10);
- 4. Knowledge of databases = 10 points (on a scale of 1 to 10);
- 5. Knowledge of Excel = 10 points (on a scale of 1 to 10);
- 6. Knowledge of geo-referencing = 10 points (on a scale of 1 to 10);
- 7. Knowledge of languages = 10 points (on a scale of 1 to 10);
- 8. Four best publications = 10 points (on a scale of 1 to 10);
- 9. Participation in research projects = 10 points (on a scale of 1 to 10).

In Phase 2, the evaluation and scoring will be as follows:

- 1. Motivation for studying mobility and territorial management = 25 points (on a scale of 1 to 25);
- 2. Experience of archiving and computer skills = 25 points (on a scale of 1 to 25);
- 3. Willingness to start work on the grant immediately and to travel as part of the project = 50 points (on a scale of 1 to 50);

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place at Palácio do Vimioso, being the candidate approved notified through e-mail. To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties. After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties.

Application deadline and submission of applications: The tender is open from <u>21 of May to 05 of June of 2024</u> and the results of the selection will be published by <u>15 of June of 2024</u>.

Applications must be formalized, obligatorily, by sending an application letter with the following documents:

- Motivation letter (1 A4 page);
- Developed curriculum vitae;
- Certificate of qualification;
- Proof of enrolment or registration on a study cycle or non-degree course;







- Other supporting documents deemed relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
