#### MASTER RESEARCH SCHOLARSHIP - 1 VACANCY

11 of September of 2024

A call is open for the award of a Master's Scholarship under the Agenda for the digital transformation of forest value chains in a more resilient and low-carbon Portuguese economy, TRANSFORM, Project P3.6 – Soil Biome – improving soil-plant relations financed by national funds through the Portuguese Recovery and Resilience Program, under the following conditions:

Scientific area: Biology, or related areas

#### Admission requirements:

Master degree in the indicated area

- Attendance of a PhD course or a non-degree course in a Portuguese higher education institution.
- Two letters of recommendation with contact details.

#### **Preferential factors:**

- Experience in monitoring field trials involving plant and soil sampling.
- Experience in laboratory techniques for analysis of soil enzymes.
- Ability to implement and optimize protocols for the evaluation of enzymatic activities.
- Mastery of statistical analysis methodologies.
- Solid knowledge of Portuguese and spoken and written English.
- Availability to travel around the country.
- Have car driving license.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.









#### Work plan:

Monitoring and collection of plant and soil samples in the test fields taking place in different areas of the country. Evaluation of physiological parameters and plant growth under field conditions. Treatment of soil and plant samples to ensure their correct packaging for subsequent analysis.

Laboratory analyses to evaluate soil microbiological activity parameters (enzymatic activity, among others), including protocol optimization. Analysis and statistical treatment of the results obtained.

In addition, the candidate must monitor and collaborate in tasks related to the management of the project and the general operation of the laboratory.

Regarding the admission requirements mentioned above, the following should be noted:

- In the case of academic degrees awarded by foreign higher education institutions, and in order to ensure the application of the principle of equal treatment to candidates who hold foreign and national academic degrees, it is mandatory to recognize these degrees and convert the respective final classification to the Portuguese classification scale.


Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law No. 40/2004 of August 18 and Decree-Law No. 123/2019 of August 28) and in accordance with the legislation and Regulation of Research Grants of the Foundation for Science and Technology, IP force, regulation nº950/2019 of December 16, 2019: https://files.diariodarepublica.pt/2s/2019/12/241000000/0009100105.pdf and other applicable rules.

Place of work: The work will be developed at the Soil Microbiology Laboratory – MED of the University of Évora, under the under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Professor Isabel Brito and Ana Alexandre who must draw up an opinion on the final activity report of the scholarship (Annex II), according to the draft in Annex III.

**Duration of the scholarship(s):** The scholarship will have a duration of 6 months, <u>starting on October of 2024</u>. The scholarship contract may be renewed up until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €1259,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM\_atualizacao-2024.pdf">https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM\_atualizacao-2024.pdf</a>), payments being made monthly, by check or bank transfer.









Selection methods: The selection methods to be used will be as follows

• Curriculum evaluation (100%)

If deemed necessary by the selection board, for further clarification or tie-breaking purposes, candidates may be invited to a selection interview. In the case of using an interview, the valuation of the evaluation elements will be as follows:

- Curriculum evaluation (80%)
- Interview (20%)

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place Department of Biology of the University of Evora – Mitra, being the candidate approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship.

**Application deadline and submission of applications**: The tender is open from <u>12 to 27 of September of 2024</u> and the results of the selection will be published by <u>30 of September of 2024</u>.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificate of qualifications.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.

#### **SECOND CLAUSE**

In the alternative, the FCT Research Grant Regulations apply, of which the Second Party declares that it is aware.

#### **THIRD CLAUSE**

The Second Party undertakes to carry out the attached work plan, the content of which he/she declares that he/she has taken full cognisance of and accepts unreservedly, from the above-mentioned start date and on an exclusive dedication basis, under the terms of article 5th of the Research Fellow Statute.









#### **FOURTH CLAUSE**

- 4. The concrete definition of the activities referred to in the previous paragraph is the responsibility of the First Party, after hearing the Second Party and the Scientific Advisor, and they must be included in the agreement to be signed, as provided for in the previous clause.


