

### Mediterranean Institute for Agriculture, Environment, and Development (MED)

### Research Scholarship for Bachelor's Degree Holders - 2 vacancies

November 25, 2024

A call is open for the awarding of two (2) Research Scholarships (BI) for a Bachelor's Degree, under the project "GEDI4SMOS: Development and testing of computationally efficient methodologies for the combined use of LiDAR, radar, and multispectral data for national characterization of vegetation cover for land occupation mapping purposes," with the reference CCA931573, funded by the Directorate-General for Territory (DGT), under the following conditions:

Scientific Area: Geography, Engineering, and Earth Sciences.

**Admission requirements**: being enrolled in a Master's degree program in one of the scientific areas mentioned in the previous point. Graduates in areas related to Geography, Engineering, and Earth Sciences, or related areas, with skills in:

- spatial modeling in Geographic Information Systems (GIS) in any thematic area, and/or;
- ii) photointerpretation of aerial or satellite images and/or processing of satellite images, and/or;
- iii) land use/land cover mapping.

According to the FCT Research Scholarship Regulations No. 950/2019 of December 16, 2019, articles 3 and 6, candidates for BI must meet, as a general condition for the awarding of the scholarship, effective enrollment in study cycles leading to the awarding of academic degrees or in non-degree courses. Non-degree courses correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of March 24 and should be developed in a higher education institution in association with at least one R&D unit, including the course plan in one or several research areas of the unit.

**Work Plan**: Develop and implement methodologies for producing land use/land cover mapping based on spatial modeling in GIS, visual interpretation of aerial and satellite images, and digital processing of satellite images, specifically mapping of interest for the Land Cover Monitorization System (SMOS) (https://smos.dgterritorio.gov.pt/).

**Applicable legislation and regulations:** The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in **Annex I**, pursuant to the Research Scholarship Statute (Law no.





40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. (Regulation no. 950/2019, of July 22, 2024). 98131/2024, of July 22, 2024), https://files.diariodarepublica.pt/2s/2024/07/140000000/0035300366.pdf and in the Research Grants Regulations of the Foundation for Science and Technology, I.P. (Regulation no. 950/2019, of December 16, as amended).

**Place of Work**: The work will be carried out at the Mediterranean Institute for Agriculture, Environment, and Development (MED) at the University of Évora, and at the headquarters of the Directorate-General for Territory in Lisbon, under the general coordination of the Administrator of the University of Évora and the scientific supervision of: Scholarship 1 - Dr. Sérgio Godinho and Dr. Pedro Benevides; Scholarship 2 - Dr. Sérgio Godinho and Dr. Hugo Costa.

**Duration of the Scholarships**: The scholarship will have a duration of 12 months, starting on January, 2025, with the possibility of renewal.

Monthly Maintenance Allowance: The amount of the scholarship is €990.98, according to the table of values for scholarships awarded directly by FCT, I.P. in the country (https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf), with payments made monthly by check or bank transfer.

**Selection Methods**: The selection methods to be used are as follows: curricular evaluation with an eliminatory character, and an interview to assess knowledge and experience, personal motivation, and interest in the position.

After ranking the candidates based on the curricular evaluation, the top 10 candidates will be interviewed. Candidates with a curricular evaluation score below 10 points will not advance to the interview stage. The final score will be the weighted average of the curricular evaluation and the interview, with the following weighting factors:

- 0.4 for the curricular evaluation;
- 0.6 for the interview.

Candidates with a final score below 10 points will not be selected for the scholarship.

The curricular evaluation will be based on the certificates of academic degrees and the documents referred to in items (iv) to (vi) of the "Documentation to be submitted" section.

The selection criteria to be used in the curricular evaluation are as follows:

- A) Bachelor's degree and/or master's degree courses in GIS and/or remote sensing (scale of 0 to 2)
  - 0 Without a degree in GIS and/or remote sensing or
  - 1 Bachelor's degree in GIS and/or remote sensing and/or
  - 2 Bachelor's degree and master's degree courses in GIS and/or remote sensing





- B) Skills in spatial analysis/modeling in GIS (scale of 0 to 6)
  - 0 No experience or
  - 3 Some experience or
  - 6 Very relevant experience
- C) Skills in interpreting aerial photography or satellite images and/or processing satellite images (scale of 0 to 6)
  - 0 No experience or
  - 3 Some experience or
  - 6 Very relevant experience
- D) Skills in land use/land cover mapping (scale of 0 to 6)
  - 0 No experience or
  - 3 Some experience or
  - 6 Very relevant experience

The score for the curricular evaluation (expressed on a scale of 0 to 20 points) will be obtained using the following formula:

Curricular evaluation score = A + B + C + D

Form of Publication/Notification of Results: The final evaluation results will be made public through a list ordered by final grade, posted in a visible and public place at the Mediterranean Institute for Agriculture, Environment, and Development (MED). Approved candidates will be notified via email.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship

**Application Deadline and Submission Process**: The competition is open from <u>December 3 to December 17, 2024</u>, and the selection results will be published by <u>December 31, 2024</u>.





Applications must be formalized, without exception, by sending a cover letter accompanied by the following documents, under penalty of exclusion:

- i) Photocopy of the citizen card or identity card and the tax identification card;
- ii) Detailed Curriculum Vitae (CV);
- iii) Photocopies of certificates of academic degrees held;
- iv) Document describing competencies in spatial analysis using GIS. This explanation should not refer to the CV but should present all curricular facts that prove the required competencies (e.g., project titles, software used), as well as the context of their acquisition (i.e., course unit, professional context);
- v) Document describing competencies in the interpretation of aerial or satellite images and satellite image processing. This explanation should not refer to the CV but should present all facts that prove the required competencies (e.g., project titles, software used), as well as the context of their acquisition (i.e., course unit, professional context);
- vi) Document describing competencies in land use/land cover mapping, e.g., DGT Land Cover Map, CORINE Land Cover Mapping, National Forest Inventory, and Parcel Mapping. This explanation should not refer to the CV but should present all curricular facts that prove the required competencies (e.g., project titles, software used), as well as the context of their acquisition (i.e., course unit, professional context).

Documents requested in points (iv) to (vi) that exceed one A4 page will not be considered.

For application purposes, proof can be replaced by a declaration of honor from the candidate. However, failure to demonstrate possession of the required degree by the application deadline or failure to present proof of enrollment or registration in a study cycle or non-degree course, for scholarships with that component, will result in the annulment of the candidate's evaluation. Academic degrees obtained in foreign countries need to be registered by a Portuguese Institution according to Decree-Law No. 66/2018, of August 16, and Ordinance No. 33/2019, of January 25. The presentation of the certificate is mandatory for contract signing.
