

# MED - MEDITERRANEAN INSTITUTE FOR AGRICULTURE, ENVIRONMENT AND DEVELOPMENT MASTER SCHOLARSHIP - 1 VACANCY

28 of November of 2024

A call for tenders is open for 1 Master Scholarship within the scope of the project "SOLVO – SOLuções baseadas em cobertura do solo com mulch e biochar procedentes de resíduos do lagar para reverter processos de desertificação nos olivais do MediterrâneO", (2022.06004.PTDC), financed by national funds through FCT/MCTES, under the following conditions:

Scientific area: Agrarian Sciences

### Admission requirements:

Master's degree in Landscape Architecture, Conservation Biology. With fieldwork experience in olive groves, vineyards and the Montado ecosystem.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

### Work plan:

The work plan for this research grant consists of:

- Laboratory and field monitoring of the short- and medium-term impacts of SOLVO (mulch-biochar) techniques on soil erosion and water storage;
- 2. Field evaluation of the carbon balance, stocks and forms of soil and sediment carbon (TOC analysis, TG-DSC) of SOLVO techniques;
- Evaluation of the environmental performance of the techniques by means of life cycle assessment (LCA) and evaluation of the mitigation of the water scarcity footprint and the carbon footprint;
- Project management, maintenance of the website, support for organizing events, management of administrative procedures and other analyses required as part of the project;







5. Promoting meetings based on participatory methodologies with focus groups and coconstruction of knowledge.

The final objective of this work is to characterize the effects of soil restoration treatments on soil ecosystem services and to assess the perception of social actors of the effect of treatments on ecosystem services, namely erosion control, water storage and carbon footprint.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. Place of work: The work will be developed at MED of the University of Évora, under the under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Professor Teresa Pinto Correia and Professor Sergio Prats Alegre, who must draw up an opinion on the final activity report of the scholarship (Annex II), according to the draft in Annex III.

**Duration of the scholarship(s):** The scholarship will have a duration of 7 months, starting on January of 2025. The scholarship contract may be renewed up until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €1 259,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM">https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM</a> atualizacao-2024.pdf), payments being made monthly, by check or bank transfer.

Selection methods: The selection methods to be used will be the following:

The selection method will consist of a points-based assessment, with a maximum of 100 points and the following criteria:

- curricular assessment, 30 points
- professional experience in the field of soil science, 20 points
- availability to start work, 10 points
- interview, 40 points

Candidates with more than 40 points in the CV and professional experience assessment will be selected for interview. In the curricular assessment, fieldwork and interviews with social actors will be highly valued. The jury reserves the right to exclude candidates who do not achieve the







minimum final classification of 50 points on a scale of 0-100 points, and may not select any candidate if it agrees that none of the candidates has the required profile.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, Certificate of qualifications, Two recommendation letters, Motivation letter.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
