Research Scholarship for Bachelor's Degree - 1 Vacancy

9 of December of 2024

A call for tenders is open for 1 Scholarship for Bachelor's Degree within the scope of the Innovation Contract "Apples to Apples" at the University of Évora, funded by the company Empowered Startups, under the following conditions:

Scientific area: Informatics

Admission requirements: To be graduated in Informatics Engineering (or related field), with proficiency in Portuguese Language. Experience in using Database Management Systems, open-source solutions and development tools, and web service development will be preferential factors.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan: The project's main objective is to implement a web application and its corresponding database to enable the collection, storage, processing, analysis, and visualization of results from neuropsychological assessments:

The following tasks are planned:

- 1. Review of the state of the art regarding the implementation of web applications;
- 2. Review of the state of the art regarding database management systems;
- 3. Specification of the database model;
- 4. Specification of the web application;
- 5. Implementation of the database;
- 6. Implementation of the web application;
- 7. Integration of the web application with the database;
- 8. Preparation of technical reports, deliverables, and materials for intellectual property registrations, and participation in technical meetings.





Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. (Regulation no. 950/2019, of July 22, 2024). 98131/2024, of July 22, 2024), https://files.diariodarepublica.pt/2s/2024/07/140000000/0035300366.pdf and in the Research Grants Regulations of the Foundation for Science and Technology, I.P. (Regulation no. 950/2019, of December 16, as amended).

Place of work: The work will be developed at Centro ALGORITMI, VISTA Lab (Video, Image, Speech and Text Analysis Laboratory) of the University of Évora, under the under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Professor Pedro Salgueiro, who must draw up an opinion on the final activity report of the scholarship (Annex II), according to the draft in Annex III.

Duration of the scholarship(s): The scholarship will have a duration of 6 months, starting in January of 2024. The scholarship contract may be renewed up to (ex.) until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to € 990.98€ according to the table of scholarships awarded directly by FCT, I.P. in Portugal (https://www.fct.pt/wp-content/uploads/2024/02/Tabela-de-Valores-SMM atualizacao-2024.pdf), payments being made monthly, by check or bank transfer.

Selection methods: The selection methods to be used will be the following: curriculum evaluation, interview and knowledge tests, with the respective valuation of 70% (seventy per cent), 15% (fifteen percent) and 15% (fifteen percent), respectively.

Advertising/notification of results: The final results of the evaluation will be publicized, through a list ordered alphabetically, by final grade obtained, posted in a visible and public location of Department of Informatics, Colégio Luís António Verney, being the approved candidate notified via email.





To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship.

Application deadline and submission of applications: The tender is open from 12 of December to 30 of December of 2024 and the results of the selection will be published by 6 of January of 2025.

Applications must be formalized, obligatorily, by sending an application letter with the following documents:

- Curriculum Vitae
- certificate of qualifications
- other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
