### Master's Research Scholarship - 1 VACANCY

14 of May of 2025

A call for tenders is open for 1 Scholarship(s) (Master) within the scope of the project DiadSEA - Transnational cooperation to improve the management and conservation of diadromous fish at sea (EAPA\_0011/2022), financed by INTERREG Atlantic Area 2021-2027, under the following conditions:

Scientific area: Biology

Admission requirements: Bachelor's degree in Biology or related fields, and a Master's degree in Marine Biology or related areas. Experience in aquatic ecology and the study of migratory species, as well as experience in fish fauna sampling in freshwater environments using electric fishing and biological sampling in fish markets. Knowledge of statistical analysis and ecological species distribution models (in an R environment). Preference will be given to candidates with a diving certification and a local skipper's license. The candidate must be fluent in both written and spoken English and Portuguese.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

**Work plan**: Support for data collection and processing: collection and processing of data obtained within the scope of DiadSea, e.g., data collected, and to be collected, in the context of activities involving professional fishing communities targeting diadromous species, and through sampling and monitoring campaigns of migratory fish using electrofishing, biotelemetry techniques, visual surveys, and biological sampling, as well as the preparation of scientific articles for publication. Support for the operational implementation of the project: planning and execution of the missions required for the technical-scientific component of the project.

**Applicable legislation and regulations:** The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in **Annex I**, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. (Regulation no. 950/2019, of July 22, 2024).  $^{\circ}$

Place of work: The work will be developed at University of Évora and MARE – Center for Marine and Environmental Sciences (FCUL campus, Lisbon), also involving fieldwork across the main national river basins, under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Professor Catarina Mateus and Doctor Joana Boavida-Portugal, who must draw up an opinion on the final activity report of the scholarship (Annex II), according to the draft in Annex III.

**Duration of the scholarship(s):** The scholarship will have a duration of 6 months, starting July of 2025. The scholarship contract may be renewed until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to € 1309,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="https://www.fct.pt/wp-content/uploads/2025/02/Tabela-de-Valores-SMM 2025.pdf">https://www.fct.pt/wp-content/uploads/2025/02/Tabela-de-Valores-SMM 2025.pdf</a>), payments being made monthly, by check or bank transfer.

**Selection methods**: The selection methods to be used will be the following: Curricular evaluation with a weighting of 30% and relevant previous experience with a weighting of 70%. If necessary, the jury will conduct an interview with a maximum of five candidates who, after analyzing the initial components, are deemed to have the most suitable profile for the nature of the tasks to be performed.

### **Composition of the Selection Jury:**

President – Prof. Dr. Catarina Mateus, 1st Member – Prof. Dr. Pedro Raposo de Almeida, 2nd Member – Dr. Joana Boavida-Portugal, 1st Substitute – Dr. Carlos Alexandre, and 2nd Substitute – Dr. Bernardo Quintella

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place Department of Biology, School of Science and Technology, University of Évora, being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate





withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship.

**Application deadline and submission of applications**: The tender is open from <u>20<sup>th</sup> of May to 3</u> <u>of June of 2025</u> and the results of the selection will be published by <u>10<sup>th</sup> of June 2025</u>.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, a copy of academic qualification certificates, proof of enrolment or registration in a study cycle leading to the award of academic degrees or a non-degree course, or alternatively, a sworn statement declaring that, at the contracting stage, they will provide proof of enrolment or registration if selected for the research grant they are applying for.

For the purposes of application, the evidence may be replaced by a declaration of honour signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrolment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
