### Research Scholarship (Master) - 1 VACANCY

May 19th 2025

A call is open for the award of a Research Grant (Master) in the scope of support for the maintenance of the associated laboratory infrastructures, namely, the Health and Environment and Bioaerosols and Aerobiology Laboratories, which includes a Cell Culture unit, which support not only the various research works but also classes of several UCs of ESDH and ECT, to be supported by Overheads funds from projects already completed (*Pollensorb - Physicochemical characterization of pollen adsorbed particulate matter present in the atmosphere, PTDC/ATP-EAM/0817/2014*), under the following conditions:

Scientific Area: Biochemical and Environmental Sciences

**Admission requirements**: Master in Biochemistry or similar, preferably with experience in monitoring and characterization of bioaerosols (using aerobiological, chemical and biochemical methodologies) and in cell culture (knowledge of maintenance methodologies and culture and handling of animal cells and cell assays).

According to the FCT Research Grants Regulation No. 950/2019 of December 16, 2019, articles 3 and 6, candidates for BI (Research Grants) must fulfill, as a condition for the award of the grant, the effective insertion in study cycles leading to the award of academic degrees or in courses that do not confer an academic degree. The non-degree courses correspond to the courses provided for in paragraph e) of paragraph 3 of article 4 of Decree-Law no. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including the course plan in one or more areas of research of the unit.

**Work plan**: Support for teaching and research activities in the CREATE Laboratories: i) Aerosol analysis - Bioaerosol sampling; identification and quantification of bioaerosols using the standardized methodology (EN 16868:2019) and molecular methods; Chemical and biochemical analysis of aerosols; ii) Maintenance of the Cell Culture Laboratory – maintenance of cell lines and support for pharmacology, toxicology and cell proliferation tests.

**Applicable legislation and regulations:** The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in **Annex I**, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable





legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. (Regulation no. 950/2019, of July 22, 2024). 98131/2024, of July 22, 2024), https://files.diariodarepublica.pt/2s/2024/07/140000000/0035300366.pdf and in the Research Grants Regulations of the Foundation for Science and Technology, I.P. (Regulation no. 950/2019, of December 16, as amended).

**Workplace**: The work will be developed at the BioAiR (Bioaerosol & Aerobiology Laboratory) and HealeR (Health & Envrinoment Laboratory) Laboratories of CREATE of the University of Évora, under the general coordination of the Administrator of the University of Évora and scientific supervision of Professor Dr. Célia Maria Miguel Antunes, who must prepare an opinion on the final report of activities of the fellowship (Annex II), according to the draft of Annex III.

**Duration of the fellowship(s):** The fellowship will last for 6 months, starting on July, 2025. The scholarship contract may be renewed up to a maximum of 12 months.

Amount of the monthly maintenance allowance: The amount of the scholarship corresponds to €1309.64, according to the table of values of the scholarships awarded directly by FCT, I.P. in the country (<a href="https://www.fct.pt/wp-content/uploads/2025/02/Tabela valores SMM\_2025.pdf">https://www.fct.pt/wp-content/uploads/2025/02/Tabela valores SMM\_2025.pdf</a>), with payments made monthly, by cheque or bank transfer.

**Selection methods**: The selection methods to be used will be the following: curricular evaluation (100 points) with the respective evaluation of the items:

a) experience in the area of the work plan (80 points; 80%), demonstrated in particular through publications (20%), scientific communications (20%), participation in the organization of scientific events (10%), participation in projects (40%), participation in relevant training actions (10%);

b) area of training (20 points; 20%).

**Form of publication/notification of results**: The final results of the evaluation will be publicized, through a list ordered by final grade obtained posted in a visible and public place of CREATE, in phase III of Colégio Luís António Verney, and the approved candidate will be notified by email. Under the terms of the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communication of the provisional list of the results of the evaluation, candidates have a period of 10 working days to, if they wish, comment on a prior hearing of interested parties. Based on the final ranking list, a selection reserve list will be constituted, to be used for the possible hiring of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the event of withdrawal of the candidate ranked first, failure to submit the mandatory documentation, or in the event that the scholarship holder cancels his/her scholarship early. In the event that none of the candidates demonstrates that they have the right profile to carry out the work plan, the jury reserves the right not to award the scholarship in the competition.

**Application deadline and form of submission of applications**: The call is open from <u>27 May to</u> 10 June 2025 and the results of the selection will be published by 17 June 2025.

Applications must be formalized, mandatorily, by sending an application letter accompanied by the following documents: Curriculum Vitae, certificate of qualifications, 1 letter of recommendation and other supporting documents considered relevant. For the purposes of application, the evidence may be replaced by a declaration of honour by the candidate, but the failure to demonstrate, in the contracting phase, the possession of the degree required at the deadline for the application or the failure to present proof of enrolment or enrolment in a cycle of studies or course not conferring a degree, for scholarships with this component, imply the cancellation of the candidate's evaluation.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law No. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25. The presentation of the certificate is mandatory for the signature of the scholarship contract.
