A call for tenders is open for 1 Scholarship for a bachelor's degree holder within the scope of the project "Understanding the dynamic patterns of quorum SENSing signals in ROOT colonization and biofilm formation", with FCT reference "2023.11316.PEX.", financed by national funds through Foundation for Science and Technology (FCT), under the following conditions:

**Scientific area:** Biological sciences, biochemistry and biotechnology

**Admission requirements:**

- Bachelor's degree in Biology, Biochemistry, Biotechnology or related areas, preferably with experience or interest in:
  - Isolation and manipulation of bacteria under aseptic conditions
  - Plant growth assays in controlled environments
  - DNA and RNA manipulation techniques
  - Knowledge of Chromatography and Mass Spectrometry
  - Analysis of next generation sequencing (NGS) data
- Preferred factor: enrollment in a Master's in Biochemistry
- 2 letters of recommendation

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

**Work plan:**

Collaborate in project tasks involving microbiology techniques applied to soil bacteria and molecular biology, including the extraction and purification of nucleic acids (DNA/RNA), as well as amplification via PCR and RT-PCR, ensuring data integrity and reproducibility. Participate in the setup and monitoring of plant assays under controlled growth conditions, as well as prepare biological samples for analysis by high-performance liquid chromatography coupled with mass spectrometry (HPLC-MS), in accordance with the project's analytical requirements.

To carry out this work plan, the candidate will be integrated into the research project team "Understanding the dynamic patterns of quorum sensing signals in root colonization and biofilm formation," with reference FCT "2023.11316.PEX," currently underway in the Soil Microbiology Laboratory of MED, University of Évora. Considering that the recruitment is aimed at a candidate currently enrolled in a Master's in Biochemistry, the execution of the proposed work plan will significantly contribute to the development of their Master's dissertation. This plan will allow for the deepening and consolidation of skills in microbiology, molecular biology, and analytical chemistry, thereby complementing the candidate's academic training and promoting the integration of the work into their scientific career path.

**Applicable legislation and regulations:** The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in **Annex I**, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. (Regulation no. 950/2019, of July 22, 2024). <sup>o</sup> 8131/2024, of July 22, 2024), <https://files.diariodarepublica.pt/2s/2024/07/140000000/0035300366.pdf> and in the Research Grants Regulations of the Foundation for Science and Technology, I.P. **Place of work:** The work will be developed at Soil Microbiology lab at Mediterranean Institute for Agriculture, Environment and Development (MED) of the University of Évora, under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Doctor Clarisse Brígido, who must draw up an opinion on the final activity report of the scholarship (**Annex II**), according to the draft in **Annex III**.

**Duration of the scholarship(s):** The scholarship will have a duration of 9 months, scheduled to start in September of 2025.

**Amount of monthly maintenance allowance:** The amount of the scholarship corresponds to 1040,98 €, according to the table of scholarships awarded directly by FCT, I.P. in Portugal ([https://www.fct.pt/wp-content/uploads/2025/02/Tabela\\_valores\\_SMM\\_2025.pdf](https://www.fct.pt/wp-content/uploads/2025/02/Tabela_valores_SMM_2025.pdf)), payments being made monthly, by check or bank transfer.

**Selection methods:** The selection methods to be used will be the following: *Curriculum* evaluation (50%), motivation letter (30%), and two letters of recommendation (20%). If necessary, an interview will be conducted with the top three (3) candidates, during which the following aspects will be assessed:

- Ability to express and communicate clearly;
- Motivation for teamwork;
- Expectations for personal and professional development;
- Verification of the professional experience stated in the *Curriculum Vitae*;
- Verification of the level of English proficiency.

**The final evaluation** will be based on the following weighting: 50% from the curriculum evaluation, motivation letter, and letters of recommendation, and 50% from the interview.

**Advertising/notification of results:** The final evaluation results will be published in a ranked list based on the final score obtained in the selection process conducted by the jury. This list will be posted in a visible and public location at the Mediterranean Institute for Agriculture, Environment and Development (MED), University of Évora, Mitra Campus, Évora, and all candidates will be notified by email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship.

**Application deadline and submission of applications:** The tender is open from **June 11 to June 25 of 2025** and the results of the selection will be published by **June 30 of 2025**.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: ***Curriculum Vitae, certificate of qualifications, letters of recommendation, an enrollment certificate/proof, and any other supporting documents considered relevant.*** For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.

#### EIGHTH CLAUSE

1. The rights and duties of the parties are those resulting from the provisions of the Research Fellow Statute.
2. The Second Party declares that he/she has read the Research Fellow Statute and the applicable Regulation(s) and undertakes to comply with their provisions.

#### NINTH CLAUSE

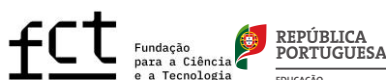
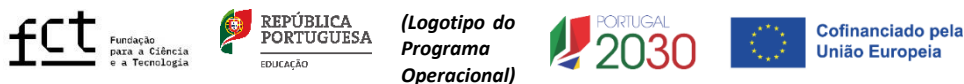
