### POSTDOCTORAL SCHOLARSHIP - 1 VACANCY

16 of June of 2025

A call for tenders is open for 1 Postdoctoral Scholarship within the scope of the project NGS (02/C05-i01.01/2022.PC644936001-00000045), financed by national funds through Plano de Recuperação e Resiliência e União Europeia – NextGenerationEU and Project POCITYF (Grant Agreement 864400), Financed by Horizon 2020, under the following conditions:

Scientific area: Physics

**Admission requirements**: PhD in physics, with experience in experimental laboratory work. Preference will be given to demonstrated multidisciplinary experience in semiconductors, electrochemistry, instrumentation, modelling, programming, and data analysis.

- Previous experience in research activities in the field of electrochemical electricity storage, particularly in the development and testing of energy management strategies for hybrid battery systems in a real operational environment.
- Knowledge of photovoltaic solar systems and their grid integration with battery systems.
- Knowledge of the implementation, commissioning, quality control tests, and communication protocols for these systems.
- Possession of a relevant Curriculum Vitae, evidenced by scientific articles published in peer-reviewed journals and presentations at international conferences.
- Participation in research projects funded through competitive national and international calls.
- Proficiency in English, with adequate skills for scientific communication and writing.

Regarding the "BIPD" (postdoctoral scholarship), in terms of the requirements to be verified for their attribution (article 7 of the FCT Research Grant Regulation no. 950/2019) the need for a doctoral degree to have been obtained in the 3 years prior to the date of submission of the application to the scholarship and, in terms of its execution, the fact that it can only be renewed for a maximum period of 3 years.

**Work plan**: The work plan focuses on the study of hybrid energy storage systems, with particular emphasis on battery technologies and their integration into renewable energy communities. Specifically, the aim is to:

- Develop optimization, sizing, and energy management tools for hybrid energy storage systems.
- Evaluate different types of battery technologies and model their operation, with a primary focus on their components, design considerations, control strategies, and applications.
- Validate the effectiveness of the developed energy storage tools and models for integration into renewable energy communities.









- Develop digital twins applied to hybrid energy storage systems.
- Provide support for the techno-economic analysis of the developed storage systems.
- Provide support in drafting research proposals aligned with the topics addressed.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. **Place of work**: The work will be developed at Renewable Energies Chair of the University of Évora, under the general coordination of the Administrator of the University of Évora and the scientific guidance of the PhD Afonso Cavaco, who must draw up an opinion on the final activity report of the scholarship (**Annex II**), according to the draft in **Annex III**.

**Duration of the scholarship(s):** The scholarship will have a duration of 12 months, starting on July of 2025. The scholarship contract may be renewed up until the end of the funding project's budget allocation.

Amount of monthly maintenance allowance: The amount of the scholarship corresponds to €1851,00, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="https://www.fct.pt/wp-content/uploads/2025/02/Tabela valores SMM 2025.pdf">https://www.fct.pt/wp-content/uploads/2025/02/Tabela valores SMM 2025.pdf</a>), payments being made monthly, by check or bank transfer.

**Advertising/notification of results:** The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place (indicate the institution's location), being the candidate (a) approved notified through (email, official letter or other).

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship.

**Application deadline and submission of applications**: The tender is open from <u>26 of June to 13</u> of July of 2025 and the results of the selection will be published by 18 of July of 2025.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: Curriculum Vitae, certificate of qualifications and other supporting documents considered relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
