Research Scholarship for Master Degree - 1 VACANCY

20 de November de 2025

A call for tenders is open for one Research Scholarship for Master, within the scope of the project "Support to the National Stranding Network – Alentejo Regional Network (ARROJAL)" financed by national funds through the Fundo Ambiental, "Monitoring of Marine Environments in the Port of Sines (MAPSi)", funded by the Port Authority of Sines and the Algarve, and "General Plan for Chemical and Microbiological Testing in the Port of Sines – General Plan", funded by the Institute of Welding and Quality (ISQ), under the following conditions:

Scientific area: Biological Sciences.

Admission requirements:

- master degree in Biological Sciences or in related areas;
- driving licence;
- diving licence and scientific diving certification;
- physical robustness indispensable to the exercise of the functions of the scholarship to which is applying;
- a valid licence issued by the competent authority for the handling, transport and collection of samples of stranded marine animals in mainland Portugal (DL 140/99 of 24 April).

Preferential factors will be considered:

- (1) experience in identifying marine mammals and reptiles;
- (2) experience in responding to marine mammal and reptile strandings and carrying out necropsies;
- (3) experience in preparing and preserving tissue samples for subsequent analysis;
- (4) experience in conducting scientific dissemination activities;
- (5) experience in screening and identifying marine sediment macrofauna;
- (6) experience in scientific work involving scuba diving.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "BI" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

Work plan:

The tasks to be carried out within the scope of the fellowship include:









- The systematic collection of information on the occurrence and distribution patterns of the main species of marine mammals and reptiles present on the Portuguese mainland coast, taking into consideration strandings of these animals that have occurred on the Alentejo coast;
- the evaluation of the main causes of mortality of stranded animals;
- the collection of biological samples that allow the characterization of the biology and ecology of the most common species of marine mammals and reptiles, contributing to the tissue bank collections of marine animals;
- the coordination of effective responses in situations of high mortalities and support to situations of live strandings;
- the increase of scientific knowledge and Ocean Literacy through the management of collected information and the dissemination of project results;
- identification of macro-organisms from rocky coastlines and marine sediments;
- statistical and graphical analysis of data;
- preparation of technical-scientific reports and scientific articles.

It is necessary to be available for frequent trips along the Alentejo coast between Troia and Odeceixe and to carry out regular work at CIEMAR and Monte do Paio.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. (Regulation no. 950/2019, of July 22, 2024).

Place of work: The work will be developed at the Marine Sciences Laboratory of the University of Évora, in Sines and at the facilities of the Instituto da Conservação da Natureza e das Florestas, in Monte do Paio (Lagoa de Santo André), under the general coordination of the Administrator of the University of Évora and the scientific guidance of the Professor João Castro, who must draw up an opinion on the final activity report of the scholarship (Annex II), according to the draft in Annex III.

Duration of the scholarship: The scholarship will have a duration of 12 months, starting during the month of January of 2026. The scholarship contract may be renewed until the end of the budget allocation of the funding projects, always taking into account the maximum duration for each type of scholarship, in accordance with Article 14 of the Research Grant Regulations of the University of Évora.

Amount of monthly maintenance allowance: The amount of the sholarship corresponds to a €1 309,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (https://www.fct.pt/wp-content/uploads/2025/02/Tabela valores SMM 2025.pdf), payments being made monthly, by check or bank transfer.









Selection methods (with the respective value in percentage): *curriculum* evaluation (30%), experience in identifying marine mammals and reptiles (10%), experience in responding to marine mammal and reptile strandings and carrying out necropsies (20%), experience in preparing and preserving tissue samples for subsequent analysis (10%), experience in conducting scientific dissemination activities (10%), experience in screening and identifying marine sediment macrofauna (10%), experience in scientific work involving scuba diving (10%).

Advertising/notification of results: The final results of the evaluation will be publicized, through a list ordered by final grade obtained, posted in a visible and public place at the Marine Sciences Laboratory, and the approved candidate will be notified by email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship.

Application deadline and form of presentation of applications: The tender is open from <u>28 November to 16</u> <u>December 2025</u>, and the results of the selection shall be published by <u>19 December 2025</u>.

Applications must be formalized, <u>obligatorily</u>, by sending an application letter accompanied by the following documents: <u>curriculum vitae</u> of the candidate and photocopy of the qualification's certificates. In the application letter, the candidate, <u>obligatorily</u>, must declare that he/she is physically fit to carry out the duties of the scholarship to which he/she is applying.

For the purposes of application, the evidence may be replaced by a declaration of honour signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrolment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.









Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.
