#### RESEARCH SCHOLARSHIP FOR MASTER- 1 VACANCY

24 of November of 2025

A call for applications is now open for a Master's Research Grant under the PRR Agenda Mobilizadora ATE project (reference no. C644914747-00000023, Activity 6.0.5 - Carnot Battery), AGERAR PLUS (reference no. 0091\_AGERAR\_PLUS\_6\_E), POCITYF (reference no. 864400) and SOLARIZE (reference no. 101131982) co-financed by the European Union's Recovery and Resilience Programme, NextGenerationEU and HEUROPE, under the following conditions:

Scientific area: Electrical Engineering, Mathematics or Management

### Admission requirements:

- Master's degree in one of the scientific areas covered by the competition or equivalent. This condition is eliminatory.
- Knowledge of the functioning of the energy market, with a focus on the electricity market. This condition is preferred;
- Knowledge of energy scenario simulation and optimisation;
- Proficiency in energy system simulation and optimisation tools. This condition is preferred;
- Good knowledge of English and Portuguese.

As set forth FCT Research Scholarship Regulation No. 950/2019 of December 16, 2019, article 3 and 6, candidates for "**BI**" (Research Grants) must comply as a rule condition for the award of the scholarship, the effective inclusion in study cycles leading to the attribution of academic degrees or in courses not leading to an academic degree. Courses that do not confer an academic degree correspond to the courses provided for in subparagraph e) of paragraph 3 of article 4 of Decree-Law No. 74/2006 of 24 March and must be developed in a higher education institution in association with at least one R&D unit, including a course plan in one or several research areas of the unit.

## Work plan:

- Support in gathering information on production assets and consumption profiles in the national electricity sector, and on current and future infrastructure (ongoing investment) for transmission and distribution;
- Implementation of an electricity transmission network simulation model with resolution at the district capital level;
- Validation of simulation results with market cost evidence;
- Implementation of additional storage assets in the simulation model;
- Analysis of market regulatory strategy for the entry of new storage assets.









- Final report and possible publication of scientific results.

Applicable legislation and regulations: The granting of the Research Scholarship will be carried out upon the signing of a contract between the University of Évora and the scholarship holder, according to the version in Annex I, pursuant to the Research Scholarship Statute (Law no. 40/2004 of August 18, as amended) and considering the provisions of other applicable legislation and regulations, namely, the Research Grant Regulations of the University of Évora (published by Order no. 8131/2024, of July 22, 2024), and the Research Grant Regulations of the Science and Technology Foundation, I.P. (Regulation no. 950/2019, of July 22, 2024). 98131/2024, of July 22, 2024), https://files.diariodarepublica.pt/2s/2024/07/140000000/0035300366.pdf and in the Research Grants Regulations of the Foundation for Science and Technology, I.P. (Regulation no. 950/2019, of December 16, as amended).

**Place of work**: The work will be developed at SOL4R of the University of Évora, under the general coordination of the Administrator of the University of Évora and the scientific guidance of the PhD Pedro Horta, who must draw up an opinion on the final activity report of the scholarship (**Annex II**), according to the draft in **Annex III**.

**Duration of the scholarship(s):** The scholarship will have a duration of 12 months, starting on December of 2025. The scholarship contract may be renewed until the end of the funding project's budget allocation, always taking into account the maximum duration for each type of scholarship, in accordance with Article 14 of the Research Grant Regulations of the University of Évora.

Amount of monthly maintenance allowance: The amount of these scholarships corresponds to €1309,64, according to the table of scholarships awarded directly by FCT, I.P. in Portugal (<a href="https://www.fct.pt/wp-content/uploads/2025/02/Tabela valores SMM 2025.pdf">https://www.fct.pt/wp-content/uploads/2025/02/Tabela valores SMM 2025.pdf</a>), payments being made monthly, by check or bank transfer.

Advertising/notification of results: The final results of the evaluation will be publicized, through an ordered list by final grade obtained posted in a visible and public place at University of Évora (SOL4R, Edifício do Anel, Mitra), being the candidate (a) approved notified through email.

To ensure the right of prior hearing of interested parties, the Final Classification project will be announced by any written means to all interested parties.

After communicating the provisional list of the results of the evaluation, candidates have a period of 10 working days to express their opinion in a preliminary hearing of interested parties. Based on the final ranking list, a reserve selection list will be drawn up, to be used for the possible recruitment of new scholarship holders within the scope of this project, up to the duration of the scholarship, which may be used in the eventuality of the first ranked candidate withdrawing, failing to present the mandatory documentation, or in the event of the scholarship holder canceling their scholarship early. In the eventuality that none of the candidates demonstrates the profile required to carry out the work plan, the jury reserves the right not to award the scholarship.

**Application deadline and submission of applications**: The tender is open from <u>02 December 2025</u> to <u>17 December 2025</u> and the results of the selection will be published by <u>24 December 2025</u>.

Applications must be formalized, obligatorily, by sending an application letter with the following documents: 1) Curriculum Vitae 2) certificate of qualifications 3) letters of reference or recommendation 4) other supporting documents deemed relevant.

For the purposes of application, the evidence may be replaced by a declaration of honor signed by the candidate, but the failure to demonstrate that evidence, in the contracting phase, possession of the required degree on the deadline for application or the non-presentation of proof of enrollment in the study cycle or non-degree course, for scholarships with this component, imply the cancellation of the candidate's application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution in accordance with Decree-Law no. 66/2018, of August 16 and Ordinance No. 33/2019, of January 25th.


